

2019 LEUKEMIA AND LYMPHOMA SOCIETY GALA TICKETS SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.

ELIGIBILITY.

To enter the Leukemia and Lymphoma Society Gala Sweepstakes (the "Sweepstakes"), you must be (a) a citizen of the United States or a lawful permanent resident of the United States; and (b) 18 years of age or older at the time of entering the Sweepstakes. The Sweepstakes is void where otherwise restricted or prohibited by law. Employees of MarineMax, Inc. PRIZES.
