EXCLUSIONS⁵

- Does not cover the actual boat on which the covered engine is installed.
- Does not cover any maintenance or other service item that is not explicitly listed as being part of the Covered Service(s) in either the Agreement or the Maintenance Schedule, including but not limited to spring commissioning services.
- Any maintenance work covered by the engine or boat manufacturer.
- Any upgraded or extra-cost products used during a Covered Service.

1 Engine Planned Maintenance coverage runs concurrently with any applicable manufacturer’s warranties.

2 All engines installed on the boat must have the same make, model, and horsepower to be eligible for coverage.

3 The Agreement term starts on the Delivery Date and expires on the earlier of: (1) the redemption of all applicable services purchased or (2) when the term of the Agreement has expired. The Delivery Date is the date shown on the registration page of the Agreement.

4 A Covered Mobile Service will be provided to perform Covered Services up to sixty (60) miles from the servicing store. Customer will be charged for any mileage incurred during the performance of a Covered Mobile Service which is in excess of sixty (60) miles at the servicing store’s current mileage rate. Per the Agreement, the definition “servicing store” means the Marine Elite Care store that is closest to the location of the Covered Engine(s) at the time a Covered Mobile Service is requested. See your Maintenance Schedule for a full list of scheduled maintenance items specific for the covered engine based on its make, model, and horsepower.
